2022/2023 (Hybrid) Training Lecture Series (20 hours in English/Italian) "Democracy and the Rule of Law: EU Law Issues" - as part of the teaching activities of the EU-DRAW Jean Monnet Module - mainly targets law and political sciences students, Ph.D. candidates of "Legal Sciences" (University of Salerno), as well as young researchers, early-stage professionals, and Ph.D./Ph.D candidates, post-doc research fellows in EU related studies from other Universities/Countries.

It is **free of charge** and a certificate is given at the end of the course to those participants who have attended at least 70% of the activities. **Online or in-person** participation in a single (or more than one) lecture(s) is allowed after **registration on the website:** www.eu-draw.com.

A number of ECTs are granted to foreign students on ICM or Erasmus+ mobility who attend at least 70% of the activities and submit a final paper. Students of the Department of Legal Sciences (Unisa) who attend at least 70% of the activities and submit a final paper can obtain from 2 to 6 ECTs in accordance with Article 10, para 5, letter d) of the Ministerial Decree n. 270/2004. The number of ECTs will be allocated by the JM teaching staff members considering both the degree of participation and the quality of the final paper.

*RESEARCH COLLOQUIUM FOR JUNIOR INVESTIGATORS

Ph.D. students and young researchers of any nationality and affiliation are strongly encouraged to enjoy the Lecture Series as speakers, in order to share and exchange views and network with other researchers in their respective fields of interest. First, they are expected to present the results of their research, and then, to engage in the debate with the keynote speakers acting as chairpersons and discussants.

For this purpose, a maximum of two junior investigators for each Lecture will be selected to discuss (online or in person) their research on the issues with the other participants. Interested young researchers are invited to send an abstract written in Italian or in English (between 1000-3000 words) together with a CV to the following address eu-draw@unisa.it by:

15th March 2023 (The future of Democracy in the European Union)
 24th March 2023 (Promoting and Protecting Values in EU External Relations)
 12th April 2023 (Quo Vadis EU? National Identities and European Values at Stake)
 21st April 2023 (The Role of Domestic Courts in Implementing the Rule of Law).

Proposals will be selected by the EU-Draw JM teaching staff members. The outcome of the selection – which is going to be conducted on the basis of the relevance to the themes of the call, and the originality and diversity of the subjects – will be announced by email.

Upon request, a reimbursement of participants' travel expenses can be considered.
